PRIVACY POLICY

1. OVERVIEW

This SMS Texting Privacy Policy governs the collection, use, and disclosure of personal information when you opt-in to receive text messages from The Cigar Cellar. By providing your mobile phone number and consenting to receive SMS messages, you agree to the terms outlined in this policy.

2. INFORMATION WE COLLECT
